DOCTORS' COMMONS.

John Bird by Divine Providence, Archbishop of Canterbury, Primate of all England, and Metropolitan, To our well-beloved in Christ *Matilda Davis Spinster* the natural and lawful daughter of *John Davis* late Chief Factor of Hudsons Bay in North America deceased *Writing: Whereas* the said *John Davis*

having whilst living, and at the Time of *his* Death, Goods, Chattels, or Credits, in divers Dioceses or Jurisdictions: did (as is alledged) in *his* Life-time rightly and duly make *his* last Will and Testament (hereunto annexed) and did *brother William Davis* and *his* sister *Ann Davis Spinster* and in the said Codicil *Thomas Vincent Esquire* Executors. And *Whereas* the said *William Davis* alone duly proved the said Will and Codicil and for some time intermeddled in the Goods of the said Deceased but died leaving part thereof unadministered. And *Whereas* the said *William Davis* survived *his* Co-Executors and died *Antistak* and *Nancy Davis Widow* the Relict of the said Deceased died without having taken upon her Letters of Administration with the said Will annexed of the unadministered Goods of the said Deceased. And *Whereas* in the Month of *January 1851* Letters of Administration with the said Will and Codicil annexed of the unadministered Goods of the said Deceased were granted to *Elizabeth Davis Spinster* the natural and lawful daughter also of the said Deceased who for some time intermeddled therein but died on or about the *15th December 1854* leaving part thereof still unadministered

AND WE, being desirous that the said Goods, Chattels, and Credits, may be well and faithfully administered, applied, and disposed of according to Law, DO therefore by these Presents grant full Power and Authority to you, in whose fidelity we confide, to administer and faithfully dispose of the said Goods, Chattels, and Credits, *twice left unadministered* according to the Tenor and Effect of the said Will: and first to pay the Debts of the said Deceased, which *he* did owe at the Time of *his* Death, and afterwards the Legacies contained and specified in the said Will, so far as such Goods, Chattels, and Credits, will thereto extend and the Law requires: You having been already sworn well and faithfully to administer the same, and to make a true and perfect Inventory of all and singular the said Goods, Chattels, and Credits, *twice left unadministered* and to exhibit the same into the Registry of Our Prerogative Court of Canterbury, on or before the last Day of *September* next ensuing; and also to render a just and true Account thereof. And we do by these Presents ordain, depute, and constitute you *Administratrix* of all and singular the Goods, Chattels, and Credits of the said Deceased (with the said Will annexed.) *twice left unadministered as aforesaid. also residuary legacies being named in the said Will.* Given at London the *thirty first* day of *March* in the year of our Lord one thousand eight hundred and *fifty six* and in the ninth year of our Regnation of

 in trust and my Executors who may be alive at my decease shall and
 in case of the death of my Wife or the death of one or more of my Ex-
 ecutors monies shall be applied as aforesaid for the use of the survivors
 Will and devise is that on the death of all my aforesaid Executors then and in
 my monies aforesaid to the issue of my two Sons John and William and to their heirs
 be alive at the decease of all my Executors I bequeath the aforesaid monies to my
 be freely appoint my Brother William Davis and my Sister Ann Davis the
 Will and I bequeath to my Brother William Davis one hundred pounds sterling and to my
 sterling to purchase a tract in remembrance of an affectionate Brother and to my Sister
 sterling likewise to purchase a tract in remembrance of me and that these be paid
 Du Quatre ventres I have decreed set my hand and seal this first day of August in the year of our Lord
 one thousand eight hundred and twenty. — John Davis —
 above named John Davis to be his last Will and Testament in the presence of us who have decreed subscribed our

Codicile

to my Will made in the presence of the great English nation and hereby
 is in presence of my Wife Ann Davis and appoint Thomas Vincent Esq^r Chief
 Factors to the Adversary Day Company a joint Executor to my last Will jointly with my Brother William and
 my Sister Ann Davis I am minded to add this Codicil to my Will on reflecting on the uncertainty of life and the
 situation I have my Wife and Children I have with particular care and pains will have been relieved from a load
 of anxiety as my right estate friend is due to write I see look up with confidence and I shall myself Thomas
 Vincent Esq^r will in case of my death except of my silver wearing watch (No: 3923) and five guineas to purchase
 a ring or other tract to keep in remembrance of me Du Quatre ventres I have decreed set my hand and seal the
 eighth day of September in the year of our Lord one thousand eight hundred and twenty two. — John Davis. —
